#### APARTMENT ASSESSMENTS

Assessments are being performed for all apartments regardless of your phase. The assessment typically takes 45 minutes. Remember, this is how we communicate your temporary relocation needs to NYCHA! Please sign up for your assessment today by visiting, calling, or e-mailing the Resident Engagement Office.



### **XRF APPOINTMENTS**

Lead paint testing is required in select apartments. If testing is required in your apartment, CMG will reach out to you directly. This appointment typically takes 2 hours. Please respond to appointment requests made by the resident engagement team to ensure we have all information needed to complete your apartment renovation.



### **AC BRACKET APPOINTMENTS**

CMG will contact you if your air conditioner requires a bracket. All existing air conditioner units must be secured with approved window brackets to ensure the safety of residents. Installation takes about an hour and you can remain in your apartment during the installation.
